

***RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS,
AND ASSUMPTION OF THE RISK AGREEMENT***

WHERE AS, in return for instruction in defense tactics and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned agrees to indemnify, hold harmless and defend Controlled F.O.R.C.E. Inc. and any of its employees, directors, officers or agents (hereinafter the "C-FORCE"), from any and all fault, liabilities, cost, expenses, claims, demands of lawsuits arising out of, related to or connected with: the course of instruction, the Undersigned's Participation in the course of instruction; the training room, buildings, land and premises used for the course of instruction (hereinafter the "Premises") the Undersigned 's presence on or use of said Premises; and all acts or omissions of the Undersigned. And should any such claim, demand of lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of The Undersigned furthermore waives for himself\herself and his\her executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he/she may have or which may arise against C-FORCE, (including illnesses suffered, but not limited to any and all injuries, damages or by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: the course of instruction; the Premises; the Undersigned's property (whether or not entrusted any State, or under and theory of law of equity, the Undersigned will indemnify, hold harmless and defend C-FORCE, from any and all costs, expenses of liability including, but not limited to, the cost of any settlement of judgment, use of premises, and made or rendered against C-FORCE, whether individually, jointly, or expenses incurred in connection with any such claim, demand of lawsuit, including attorney's fees to C-FORCE); and training instruction. C-FORCE shall not be liable for, and the Undersigned, on behalf of himself\herself and his/her executors, administrators, assignees or heirs, hereby expressly releases C-FORCE from any and all such claims.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, instruction of defense tactics training.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands, and will at all times abide by all C-FORCE rules and training instructions.

This instrument binds the Undersigned and his/her executors, administrators, assignees, or heirs.
